**PWEA** is an industry association active since 1999, with over 180 members: investors, developers, turbine and component manufacturers.

PWEA groups key industry players from abroad, as well as Polish entrepreneurs – investors, producers and service providers across the entire onshore & offshore wind supply chain.

PWEA supports and promotes the development of wind energy, and its aim is to create favorable conditions for investing in wind

energy in Poland and to systematically increase the use of wind energy as a clean source of electricity generation. The overriding goal of the Association is to work to improve the existing and create new legal provisions as well as to increase political and social awareness in the field of wind energy.

PWEA activity includes active participation in consultations of legal acts (laws, regulations), strategies, policies and sector programs, as well as close cooperation with decision-makers, education and dissemination of knowledge about wind energy.

Each company member has a right to appoint one representative to be an ordinary member in PWEA.

PWEA has an advisory body to the Board - **Steering Committee**, which skills are i.a.: initiative in preparing proposals for determining the directions of the Association's activities, opinions on the directions of the Association presented by the Board, opinions of

relevant positions of the Board, developing positions and proposed solutions within the thematic groups.

The Steering Committee has established working groups to different areas of the sector. Few sub working groups are active in the areas e.g.: offshore wind, offshore permitting, cable pooling, green hydrogen, "10h rule" act, O&M, certification, corporate PPAs, grid interconnection, energy market.

Each company joining PWEA gains affiliate status with two foundations established at the initiative of PWEA: RE-Source Poland Hub Foundation and Wind Industry Hub Foundation.



**The RE-Source Poland Hub Foundation** was established in July 2019 to support the energy transition in Poland. The RE-Source Poland Hub Foundation is a Polish platform for cooperation between RES energy consumers and producers. The aim of the Foundation is to enable companies in Poland to build competitive advantages based on cheap and clean energy from renewable sources. The Foundation is taking steps to create a regulatory environment conducive to the acquisition of clean, green energy by companies, for example in the form of cPPAs.

Membership fees are paid on a one-off basis in advance for 12 months.

Additionally each new supporting member is obliged to pay the joining fee in amount of 50% of base rate.

Membership fees are yearly indexed with the indexation ratio in the amount of max. 5% of the base rate.

1. Your candidature will be introduced to the Steering Committee and to the Board for a procedural acceptance.
2. After the acceptance you will be asked to pay annual membership fees.
3. When the payment is on PWEA bank account the PWEA Board will take a formal resolution on admission of new member.
